

WQDR RULES & REGULATIONS: [QDR Great Escape] 4.2.18-4.13.18

HOW TO WIN: The QDR Great Escape to Stagecoach Music Festival contest will run Monday – Friday between 4.2.18-4.13.18. Listen to qualify at 7:21a, 11:21a, 1:21p, and 4:21p ET. Be caller #9 when you hear the cue to call. Instantly win \$50.00 and qualify for a trip for (2) for 4 days and 3 nights to California for the Stagecoach Festival. The Grand Prize Winner will be randomly selected from all qualifiers on Monday, April 16 with the Q Morning Crew.

Only one qualifier per household in the two week period of the QDR Great Escape to Stagecoach.

Trip will include:

Our bus will depart Riverside Marriott to Stagecoach: Friday, April 27th at 5:00 PM - Saturday, April 28th at 1:00 PM and at 6:00 PM - Sunday, April 29th at 1:00 PM and 6:00 PM - Once the 5:00 PM bus departs on Friday & 6:00 PM bus departs on Saturday and Sunday from the Riverside Marriott, it will not return until the Stagecoach Music Festival Concert is concluded for the evening;
- The Trip must be taken from Friday, April 27th through Monday, April 30th. Trips not taken during and between these dates are subject to forfeiture without rescheduling;
- Lodging accommodations to include only room base rate and applicable state & local taxes;
- The Riverside Marriott is a Smoke Free Facility. No Smoking is allowed in Guest Rooms, Courtyards, Pool, Public Areas or Restaurants.

- Haas Entertainment or Sponsoring Record Label will reserve, book and secure roundtrip coach class airline transportation for the Trip Winner and their Guest;
- Trip Winners and/or Station may be responsible for completing mandatory Record Label Promotional Support Information and to fax or email it to Haas Entertainment before flights can be booked;
- Trip Participants are responsible for transportation to and from the airport they will be flying out of and back in to and if applicable any airport parking fees;
- Trip Participants will be flown into and out of Ontario (California) International Airport;
- Trip Participants may be required to fly out of and back into the closest MAJOR market airport to the city of their Sponsoring Station;
- Airline tickets are booked on the open market. Roundtrip coach class airfare will include base fare, taxes, passenger facility charges and security fees;

- Trip Participants are required to fly on the same flights together. If any Trip Participant wishes to fly out of or back at a different time or date or from a different city, then the Trip Participant is responsible for any difference in airfare;
